OUR PURPOSE

As Bodrum Private Marmara Primary School, we aim to protect our children in accordance with the relevant articles of the United Nations Convention on the Rights of the Child and the Turkish Civil Code, the Convention on the Rights of the Child, to eliminate the behaviors that prevent their physical, social and emotional development, and to provide positive behavioral change by adhering to social values.

OUR PRINCIPLES

- Bodrum Private Marmara Primary School accepts and respects all decisions that protect the rights of national and international children and care about their physical, spiritual and emotional development.
- Bodrum Private Marmara Primary School creates an environment where every child has the right to freely express their views and to express their opinions on any issues that concerns them.
- Bodrum Private Marmara Primary School reminds parents within the scope of school family- child cooperation that those responsible for the child, especially the parents, are responsible for respecting childen's rights while making efforts to implement the rights.
- Bodrum Private Marmara Primary School recognizes the importance of mass media fort he development of the child. It also tries to protect children from all kinds of harm that mass media can cause.
- Bodrum Private Marmara Primary School makes the arrangements to ensure the development of the children to the maximum level. Program of Inquiry is organized in a way that will increase the children's tolerance, respect for their own culture and different cultures, non-discirmination and respect for nature.
- Bodrum Private Marmara Primary School makes sure that children can participate in playgrounds, children's clubs, library, sports and cultural centers so that they can gain intercultural awareness and become life long learners by implementing their learner profile attributes and approaches to learning.
- Bodrum Private Marmara Primary School cannot punish the children in any way by inhumane or humiliating metthods. The school shows the necessary care in this regard.









- Bodrum Private Marmara Primary School offers a suitable educational environment for its students with its positive school culture, improved physical infrastructure, rich content education planning, expert education staff, qualified personnel, and a school environment where they know they can talk and really rest.
- Bodrum Private Marmara Primary School creates procedures that will increase the functionality of the Child Protection policy, which will ensure the benefit of children in any decision or measure taken, and ensure its dissemination and implementation.
- Bodrum Private Marmara Primary School advocates that all students have equal rights to protection regardless of their interests, abilities, culture, race, language, religion, gender identity.
- Bodrum Private Marmara Primary School cares about the health of every student and offers the right to work, be present and be treated in a healthy environment.
- Bodrum Private Marmara Primary School ensures that employees of the institution and all stakeholders who serve the institution internally or externally, are provided with the necessary training or support, so that they can recognize, prevent and intervene in child protection risks and events that may arise.
- Bodrum Private Marmara Primary School adopts strong communication skills and solutionoriented approach while fulfilling the requirements of the Child Protection policy.

OUR RESPONSIBILITIES

Bodrum Private Marmara Primary School is obliged to prepare, implement and control the Child Protection Policy and its procedures, to fill accurate and up-to-date documents in all cases related to matters requiring explanation on the protection of children, annually review the Child Protection Policy and procedures and ensure their effective and correct implementation, and legal framework to ensure confidentiality. School principle and concellors are responsible for these. Creating a positive school climate, it considers the mental, physical and social development of children as its top priority service.

APPLICATIONS

- . Bodrum Private Marmara Primary School evaluates the terms of the Child Protection Policy and prevents any negative situation to occur in the open or closed areas where educational activities are carried out, controls the risks and takes the necessary measures.
- · Bodrum Private Marmara Primary School prevents negative words and behaviors that adversely affect educational practices and takes measures to prevent them.
- · During the recruitment process of the administrators, teachers and staff in Bodrum Private Marmara Primary School, they are expected to comply with the child protection requirements and to make a commitment to fulfill their principles.
- · It is essential to inform the administrators, teachers and staff of Bodrum Private Marmara Primary School about the contents of the Child Protection Policy. It does what is necessary for the planning of the trainings.
